Dogs may be registered for a 1 yr, 3 yr or permanent license. Complete each line of the application for your dog(s). In particular, choose your "Term" (1-Year, 3-Year, or Permanent--see term codes below) and fill in "Fee Paid" based on the fee structure above. 3-Year and Permanent Licenses may only be purchased in person or by mail at the Shelby County Auditor's Office.

No Refunds Permitted.

Register your dog on-line at www.shelbycountyauditors.com. Credit card payments only; license processing fee applies, as well as a 50 cent postage fee per order.

IN PERSON OR BY MAIL

1. Complete this form. Be sure the correct owner, street address, and pet description(s) appears on application.
2. Use this form to register 1 to 5 dogs. If you have more than 5 dogs, please list them on a separate sheet of paper and return it with this form. Ohio law requires a license for every dog more than 3 months old.
3. If you no longer own the dog(s) please contact the Shelby County Auditor's Office.
4. Enclose a check or money order for the correct fees payable to: **Shelby County Auditor**. Please do not send cash.
After January 31, statutory late penalty increases the licensing rate. See above.
Your application cannot be processed without the correct fees.
5. Please return the application, check or money order, and a self-addressed stamped envelope. A receipt will be returned to you with your 2016 license(s).

You may purchase the 1 year, 3 year and Permanent license(s) in person at the Shelby County Auditor's Office, 129 East Court St, Sidney or you can purchase the 1 year and kennel licenses at the Shelby County Animal Shelter, 1100 Clem Rd, Sidney. Certificates of registration and registration tags shall be valid only during the CALENDAR year or years for which they are issued. ORC Sec 955.09.
