

**SHELBY COUNTY COMMON PLEAS COURT
PROBATION SERVICES FUND
ANNUAL REPORT
NOVEMBER 24, 2014**

The Shelby County Common Pleas Court instituted the probation services fund in February of 2008. The carryover balance in the probation services fund from December 31, 2013 was \$99,126.80.

In January of 2014, the probation services fund was budgeted as follows:



As of October 31, 2014, the balance in the probation services fund was \$95,241.06. We estimate that the balance in the probation services fund by December 31, 2014 will be \$97,500.00, with anticipated revenues and expenditures in the foregoing categories.

It is our estimation that during 2015, \$36,000.00 will be collected and deposited with the Shelby County Treasurer for probation services and drug testing fees. It is our estimation that during 2015, \$42,500.00 will be expended from the probation services fees fund.

As of October 31, 2014, the Shelby County Adult Probation Department was monitoring 251 offenders placed on community control by the Shelby County Common Pleas Court. There were 132 new people placed on community control through October 31st. There are 3 full-time probation officers in the department, one of which is an intensive supervision officer funded by the CCA grant. From January 1, 2014 through October 31, 2014, the probation officers performed 144 home visits, handled 3,058 office visits, and 736 collateral contacts (telephone contacts, counsel, employment, education, etc.). The department prepared 63 judicial release reports for the Judge, filed 136 probation violations and gave 790 drug tests to probationers.
