# Winter Application of Manure in Ohio

## ADAPTED FROM CROP OBSERVATION AND RECOMMENDATION NETWORK ARTICLE

Most producers have had the needed dry weather this fall to get livestock manure applied to fields. However, a wetter than normal corn crop and full elevators, did delay corn harvest longer than normal in some areas. For livestock producers waiting on frozen ground to apply manure, here are some things to keep in mind. Frozen ground would be soil that you cannot inject the manure into or cannot conduct tillage within 24 hours to incorporate the manure.

Permitted farms are not allowed to apply manure in the winter unless it is an extreme emergency, and then movement to other suitable storage is usually the selected alternative. Several commercial manure applicators have established manure storage ponds in recent years to help address this issue.

In the Grand Lake St Marys (GLSM)watershed, the winter manure application ban from December 15th to March 1st is still in effect. Thus, no manure application would normally be allowed in that time period. The Natural Resource Conservation Service (NRCS) Code 590 was revised in 2020 and now applies statewide in Ohio (except to GLSM). It states the surface application of manure on frozen and snow-covered soil is not acceptable. An emergency exists as a temporary situation due to unforeseen causes and after all other options have been exhausted. In this situation only limited quantities of liquid manure shall be applied to address manure storage limitations until non frozen soils are available for manure application. All applications of liquid manure to frozen and snow-covered soils must be documented in the producers' records and must follow certain criteria ([see original article for criteria](#)). For farmers with solid manure, stockpiling could be an option. There are two different types of stockpiles: Short term and long term.

The short term stockpile information can be found in NRCS FOTG 318 Short Term Storage of Animal Waste and Byproducts Standard (“NRCS 318”). Essentially, short term stockpile is a pile of solid manure that is being kept temporarily in one or more locations. It is considered a temporary stockpile as long as the pile is kept at the location for no more than 180 days and stockpiled in the field where the manure shall be applied. Setback distances listed in NRCS 318 should be followed to prevent discharge to waters of the state. There are multiple recommendations listed in NRCS 318 that speaks to location, timing, and preventative measures that should be taken while stockpiling the manure short term.

The long term stockpile information can be found in NRCS FOTG 313 Waste Storage Facility Standard (“NRCS 313”). Long term stockpile is directly related to solid manure being piled and kept at a facility for longer than 180 days at a permanent location. It is recommended that all permanent long term storage stockpiles should be following the guidelines in NRCS 313 with the utilization of a stacking facility and the structural designs of fabricated structures. A stacking facility can be open, covered or roofed, but specific parameters should be in place to prevent manure runoff from the site. These recommendations are listed in the NRCS 313.

Due to the delayed harvest this past fall, the Ohio Department of Agriculture extend the 2023 cover crop seeding deadline to November 15, 2023. This allowed producers an extra two weeks to plant overwintering cover crops and still be eligible for H2Ohio payments. In Shelby County, H2Ohio producers reported 6,391.9 acres of completed overwintering cover crops. Out of those acres, 1,228.4 acres were planted by September 30, 2023, making them eligible for a \$10.00 early seeded cover crop bonus.

If you have not reported your 2023 cover crops to Shelby SWCD, please do so as soon as possible. H2Ohio requires producers to turn in a seed tag and bill for cover crops. Bin run cover crops require a seed analysis to be completed and turned in. Producers must also report how many acres were completed and be able to provide a seeding date(s). Cover crops must remain undisturbed until Friday, March 15, 2024. They also cannot receive any nutrient applications until after the March 15th deadline to be eligible for H2Ohio payments. Shelby SWCD will be doing field checks to verify that cover crops are still in place.

## NATURAL RESOURCES CONSERVATION SERVICES UPDATES

### Popular NRCS Conservation Program Expediting Rankings, Funding Contracts

Ohio producers interested in the popular Environmental Quality Incentives Program (EQIP) and Inflation Reduction Act – Environmental Quality Incentives Program – (IRA-EQIP) funding can take advantage of the ACT NOW process, which immediately approves and obligates applications when the application meets or exceeds a state-determined minimum ranking score. Applicants will experience a targeted, rapid streamlined application and contract approval process.

"This process allows us to fund promising projects immediately, rather than waiting for all applications to come in for the fiscal year," said Ohio State Conservationist John Wilson. "I urge producers and landowners to take advantage of this flexibility."

EQIP and IRA-EQIP provide financial and technical resources to producers and landowners to improve their operations, commodity production and environmental benefits. Conservation opportunities exist in cropland, forestry, pasture operations, seasonal high tunnels, socially disadvantaged producers, conservation activity plans, on-farm energy, and organic/those transitioning to organic. Producers transitioning to organic self-certify that they agree to develop and work toward implementing an Organic Systems Plan (OSP), as required by the USDA National Organic Program (NOP). Special projects are also available to address water quality, forestry management, improving pollinator populations and wildlife habitat, pasture improvements, and more.

Historically underserved producers are eligible for advance payments for all EQIP practices. This option provides historically underserved producers with funding up-front, for at least 50% of the payment rate for each practice. Historically underserved producers include producers who are beginning, socially disadvantaged, veteran, or limited resource.
