In case of your failure to appear, or otherwise respond as required by the Ohio Rules of Civil Procedure, the Plaintiff may proceed in pursuing its complaint alleging that the subject child is Abused, Neglected and Dependent, and furthermore seeks appropriate custodial placement of the child, thus affecting your parental rights.

This notice was posted pursuant to Ohio Juvenile Rule 16 and corresponding local rules for seven consecutive days from Sept. 29, 2022, to October 5, 2022.
